Sir,

J.S.P.S Govt. Homoeopathic Medical College, Ramanathapur, Hyderabad is functional since 1979 and has applied for permission for sanction of UG (BHMS) course with 125 seats including EWS quota and 38 seats including 8 seats in EWS quota in PG course in 07 subjects Homoeopathic Philosophy, 07 seats in Repertory, 04 seats in Homoeopathic Pharmacy, 04 seats in Practice of Medicine, 04 seats in Paediatrics and 04 seats in Psychiatry for the academic year 2024-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the application, the Medical Assessment and Rating Board has observed the following shortfalls as per MSR requirements:

**a) Miscellaneous**

- College has not enabled the Adhaar Enabled Biometric Attendance system (AEBAS).
- Form 16 is not from traces portal
- Acquittance of staff is not uploaded

Considering the above observations and facilities available, Medical assessment and Rating board has decided to issue **Conditional Permission** to J.S.P.S Govt. Homoeopathic Medical College, Ramanathapur, Hyderabad- 500013 for continuing UG (BHMS) course with intake capacity of 125 seats including EWS and 38 seats for PG M.D (Hom) in 07 subjects with 08 seats in Homoeopathic Materia Medica, 07 seats in Homoeopathic Philosophy, 07 seats in Repertory, 04 seats in Homoeopathic Pharmacy, 04 seats in Practice of Medicine, 04 seats in Paediatrics and 04 seats in Psychiatry for the academic year 2024-2025.

All deficiencies noticed shall be rectified within a period of one month and the compliance report shall be submitted for verification.

It is further to mention that all admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the intake capacity of 125 UG seats and 38 PG seats shall be treated as All India Quota .The counseling for seats under All India Quota shall be conducted by respective counseling authority as designated by Central Government /NCH for the A.Y 2024-25 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of the State/UT.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.


**Permission to college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR 2013 anytime during the academic year.**
